RAPID TSH CASSETTE

The **CLIAwaived,TM Inc. Rapid TSH Cassette** is an immunoassay for the qualitative determination of human thyroid stimulating hormone (TSH) in whole blood samples. This test is intended to detect TSH at concentrations > 5mlU/L. It is intended for use by medical professionals to screen an ambulatory adult population for primary hypothyroidism.



Remove test cassette and pipette from foil pouch by tearing at notch at corner of pouch. Place the cassette on a hard flat surface with the windows facing up.



Add one drop of whole blood directly into circular specimen well "S" located in the lower portion of cassette with pipette provided in the pouch. Discard pipette into waste container after use. Set timer and wait 90 seconds before proceeding.

Add 4 full drops of buffer into the circular specimen well "S" located at the bottom of the cassette.



Set timer for 10 minutes. Do not move the cassette during this time.



At the end of 10 minutes, read the line(s) in the rectangular results window of the cassette. Do not move the cassette until you have checked the lines. Do not read results after 15 minutes.
